

DOUGLAS EDUCATION CENTER ANNUAL SECURITY REPORT AND CAMPUS SECURITY POLICY

Douglas Education Center is committed to providing a safe environment for students to learn and staff to work.

The following campus security policies and procedures are applicable at Douglas Education Center.

SECURITY POLICY

Campus Security Authority

Douglas Education Center does not have a campus police or security department.

While any official who has significant responsibility for student and campus activities is a campus security authority, Douglas Education Center specifically identifies Senior Financial Aid Coordinator & Title IX Coordinator, Michael Crosby, as its Primary Campus Security Authority. All Authorized Officials as well as Executive Staff are considered Secondary Campus Security Authorities. Campus security authorities do not have the power to arrest individuals. However, Douglas Education Center will contact local police authorities to report criminal activity.

Students and staff should report all incidents of criminal offenses and security concerns to the Campus Security Authority. The Campus Security Authority will determine if a timely warning should be issued to students and staff.

In addition to the authorized officials listed, the President/CEO may initiate, or designate any member of administration, staff or faculty, to be an authorized official, as necessary.

REPORTING CRIMES

If a crime is in progress or a health emergency exists, students and staff should immediately contact police, fire, or ambulance services as necessary. Shortly after contacting emergency personnel, students and staff must contact the Campus Security Authority.

Students and staff should report non-emergency situations to the Campus Security Authority.

Individuals reporting a crime or security issue to the Campus Security Authority will be asked to complete an incident report. Information on the form will be used by the Campus Security Authority to investigate reports of crimes and security violations. Local police will be contacted, if not already called, as deemed appropriate.

Victims or witnesses of a crime may report the crime (or alleged crime) voluntarily and confidentially for inclusion in DEC's crime log and possibly in the annual disclosure of crime statistics. The victim or witness should report crimes to the Primary Campus Security Authority, Michael Crosby.

Following a reported crime, the Campus Security Authority will determine if a timely warning should be issued to students and staff due to a continuing threat. The Campus Security Authority may consult with local police to assess the threat level.

The Campus Security Authority will track all reports of crimes and security incidents including dates, times, involved parties, and the resolution.

As required, Douglas Education Center submits its Annual Security Report statistics to the U.S. Department of Education. The Primary Campus Security Authority is responsible for submitting data.

DAILY CRIME LOG

Douglas Education Center's Primary Campus Security Authority maintains a daily crime log including the date the crime was reported, the nature, date, time, general location and disposition of the complaint. The log is available to the public except when doing so would jeopardize the confidentiality of the victim, the alleged perpetrator, or an ongoing investigation.

Douglas Education Center does not have a campus police or security department and is, therefore, exempt from federal regulations requiring the maintenance of a daily crime log. DEC is doing so in a modified format to track criminal offenses and provide a basis for issuing timely warnings.

DAILY FIRE LOG

Douglas Education Center's Primary Campus Security Authority maintains a daily fire log including the date the fire occurred, the nature, date, time, general location, information on injuries and building damage. The log is available to the public.

Douglas Education Center does not have on-campus student housing and is, therefore, exempt from federal regulations requiring the maintenance of a daily fire log. DEC is doing so in a modified format for informational purposes.

BUILDING ACCESS

Students, employees, and the public can access Douglas Education Center facilities during normal business hours and other times by appointment. Business hours vary by location.

Students, staff, and the general public must access the school via the front entrance located in the Mona Ruth Imbrescia Welcome Center.

Douglas Education Center locks all entries to the school when closed. Douglas Education Center only issues keys to authorized individuals or to those responsible for opening the school in the morning and closing it at night.

Electronic entry systems are installed in six DEC buildings (8th St Arts Building, Van Keulen Complex, The George A. Romero Filmmaking Building, 456 Donner Ave, The Cosmetology Academy (access to the clinic area does not have an electronic entry system), and 30 Donner Place). These systems require an electronic key fob to gain access to the aforementioned buildings. These systems are controlled by the Information Technology Department and key fobs are assigned by the Information Technology Department. Access levels are set within the system to restrict access at certain times, days, or to certain buildings. Upon the students' graduation or withdrawal, their key fobs are immediately disabled. Upon an employee's resignation or termination, their key fob is immediately disabled. If an applicable emergency situation presents itself, DEC has the ability to fully restrict access to the fobbed locations.

All Douglas Education Center facilities are equipped with video surveillance for daily monitoring and increased security.

SECURITY PROGRAMS

The Primary Campus Security Authority is responsible for arranging security and safety programming for students and employees. The Primary Campus Security Authority provides training to inform students and staff about campus security policies and procedures at Douglas Education Center annually by October 1. All

students and staff are encouraged to be responsible for their own security and the security of others.

Douglas Education Center provides a Drug and Alcohol Abuse Prevention Program that addresses alcohol and drug abuse prevention annually by October 1. All students and staff receive the DEC Drug and Alcohol Abuse Prevention Policy via direct email. The policy addresses the standards of conduct that prohibits the unlawful possession, use or distribution of illicit drugs and alcohol, the DEC imposed sanctions on students and employees, and legal sanctions for violation of alcohol and drug laws, health risks, and information for available professional counseling/treatment services.

Douglas Education Center provides a campus sexual assault program to promote the awareness of rape, acquaintance rape, and other forcible and nonforcible sex offenses. The educational program utilized is provided by Vector Solutions and entitled "Not Anymore." "Not Anymore" is an interactive online program designed to prevent sexual assault, dating and domestic violence, and stalking. DEC requires this program to be viewed by each student within two weeks after starting classes. Incoming students are also given an overview about the DEC's Title IX policy, reporting options, and resources during student orientation.

In addition to these programs, the Title IX Coordinator also schedules other educational programs throughout the year which focus on sexual violence, dating violence, domestic violence, and stalking. These as well as other safety and security programs may be conducted throughout the year. Individuals with program suggestions are encouraged to share them with the Title IX Coordinator, the Academic Affairs Coordinator, or the Public Safety Coordinator.

ALCOHOL VIOLATIONS

Douglas Education Center prohibits students from the unlawful manufacture, distribution, dispensation, possession, sale or use of alcohol or being under the influence of the same while attending or participating in school related activities on or off the school grounds. Douglas Education Center may refer individuals in violation of state and city underage drinking laws to police. A violation of these, or any of Douglas Education Center's alcohol abuse prevention policies, is cause for dismissal.

DRUG VIOLATIONS

Douglas Education Center prohibits students from the unlawful manufacture, distribution, dispensation, possession, sale or use of controlled substances or being under the influence of the same while attending or participating in school related activities on or off the school grounds. Douglas Education Center will refer individuals in violation of federal, state, and local drug laws to police. A violation of these or any of Douglas Education Center's drug abuse prevention policies is cause for dismissal.

WEAPONS VIOLATIONS

DEC believes an effective learning environment is one that is free of weapons that threaten students, employees, volunteers or visitors. Therefore, DEC has a weapons-free policy to minimize any harm or threats to students, employees, volunteers, and visitors. Any student or employee who violates this policy will be disciplined accordingly. Such disciplinary action may include dismissal, discharge, and/or appropriate legal action.

SEX OFFENSES

Douglas Education Center prohibits all forms of sexual discrimination as required by Title IX of Education Amendments of 1972. This includes sexual violence, dating violence, domestic violence, and stalking.

It is the option of victims of domestic violence, dating violence, sexual assault and/or stalking to notify Administration, Monessen Police Department, and/or the Pennsylvania State Police of any crime committed against them. If you are a victim of domestic violence, dating violence, sexual assault and/or stalking at DEC, your first priority should be to get to a place of safety. You should then obtain the necessary medical treatment as advised by a medical professional. Administration strongly advocates that a victim of violence report the incident in a timely manner. You can call 911 or DEC's Title IX Coordinator, Michael Crosby, at 724-653-2196. This is a critical factor for evidence collection and preservation. Notifying Administration will not obligate the victim to prosecute, nor will it subject the victim to scrutiny or judgmental opinions from staff. Allegations of sexual assault or rape occurring off campus should be reported to the Monessen Police Department.

If the crime occurred on campus DEC authorities may issue a safety alert to those areas of the campus community affected by the crime. The issuance of this alert will depend on the particular circumstances of the crime.

While Douglas Education Center has no on-site professional counseling staff, the TIX Coordinator or authorized individual will provide a list of available resources.

If more comfortable, a student or employee may report an allegation of a sex offense to a Douglas Education Center staff member other than the TIX Coordinator. All DEC employees, except those designated as Confidential Employees, are considered Mandated Reporters. This means that once information is disclosed to a Mandated Reporter they are required to report that information to the Title IX Coordinator. Before a person discloses any information to a Mandated Reporter, the Mandated Reporter should ensure that this person is aware of the reporting obligations of the Mandated Reporter.

Individuals who are designated as Confidential Employees are able to offer support and resources and will not share information with the Title IX Coordinator or any other employee of Douglas Education Center without the express permission of the disclosing party to the extent permissible by law while still ensuring compliance with other reporting obligations. For example, complaints involving minors are subject to mandatory reporting requirements.

A victim has the option of whether or not to file a Complaint regarding the sexual offense. If the victim chooses to file a Complaint, the matter shall be handled with either the school's *Title IX Non-Discrimination & Grievance Process Policy* or the school's *Institutional Sexual Misconduct Policy*. While there is no set time frame for resolution, the institution strives to resolve all cases in a timely manner while maintaining fairness and equality to all parties involved.

During the Grievance Process alleged sex offenses will be investigated by a Title IX Investigator. Following the investigation and evaluation of all relevant and not otherwise impermissible evidence a determination will be made by the Title IX Decision-Maker. Both parties will receive written notices of their rights and what to expect during the complaint process. Additionally, the Complainant will be informed of their options to notify and report to the police or local or state authorities.

During an investigation, the institution will make every effort to respect and maintain the confidentiality of all involved parties as long as that confidentiality does not pose a safety risk to the rest of the institution.

Whether or not a Complaint is filed, Douglas Education Center will offer supportive measures. Supportive measures are non-disciplinary, non-punitive individualized services offered as appropriate, as reasonably available, and without fee or charge to the parties to restore or preserve access to the DEC's

education program or activity, including measures designed to protect the safety of all parties or the DEC's educational environment, and/or deter harassment, discrimination, and/or retaliation. Supportive measures are offered as soon as the Title IX Coordinator receives a report or complaint alleging possible sexual harassment.

Douglas Education Center's internal disciplinary proceedings are separate and distinct from any legal actions taken by the complainant or against the respondent.

PERSONAL SAFETY

Douglas Education Center policies and programming encourage students and staff to accept full responsibility for their own personal safety and the safety of others. Douglas Education Center makes safety and security programming available throughout the year. Students and staff are strongly encouraged to take advantage of those opportunities.

Students and staff should observe the following safety tips:

- Secure all valuables. If possible, leave valuables at home. Do not leave personal belongings in unprotected, open areas. Engrave items with your name.
- Lock your car doors.
- Be aware of your surroundings.
- Don't walk alone.
- Report suspicious persons or circumstances to the Campus Security Authority.

While not liable for criminal activity on campus or during school activities, Douglas Education Center is concerned that students and staff are able to learn and work in a safe and crime-free environment. Douglas Education Center cannot guarantee personal safety, but has security policies and procedures in place to assist individuals. When a crime is committed, students and staff should report it to the Campus Security Authority for reporting to police, tracking, and resolution.

POLICY DISSEMINATION

Enrolled Students and Employees

DEC publishes its Annual Security Report and Campus Security Policy by October 1st of each year. By October 1st of each year, enrolled students and current DEC employees are provided with the updated Annual Security Report and Campus Security Policy by postal mailing, email or direct distribution.

Prospective Students and Employees

Prospective students and employees are made aware of the availability of the Annual Security Report and Campus Security Policy and are provided a statement of the report's availability, a description of its contents, and an opportunity to request a copy. Upon request, a copy of the policy and report are provided by postal mailing, email or direct distribution.

This report is also displayed in the DEC Learning Resource Center. Additionally, this report will be made available at any time to enrolled students and current employees, upon request. Requests can be made through the Admissions Department located in the Welcome Center.

The Director of Admissions is responsible for ensuring the distribution of this report to prospective and current students.

The Director of Career Services is responsible for ensuring the distribution of this report to newly hired employees and will provide the necessary statement to prospective employees.

The Director of Financial Aid is responsible for ensuring the distribution of this report to active students and employees.

TIMELY WARNINGS

Douglas Education Center will provide a timely warning to the school community whenever the campus authorities have determined that a serious or continuing threat to students and employees exists. The following crimes, whether reported to the campus authorities or the police, are considered to represent a threat to students and employees:

- criminal homicide including (a) murder and non-negligent manslaughter, and (b) negligent manslaughter;
- forcible and non-forcible sex offenses:
- robbery;
- aggravated assault;
- burglary;
- motor vehicle theft;

- arson;
- arrests for violations of liquor and drug laws;
- arrests for illegal weapons possession;
- persons not arrested but referred for campus disciplinary action for liquor, drug, and weapons violations; and
- crimes listed above or otherwise result in bodily injury that show evidence of prejudice based on race, gender, religion, sexual orientation, ethnicity, or disability.

In addition to these examples, timely warnings may also be issued for other crimes that campus authorities have determined may pose a serious or continuing threat to the community, such as violent crimes or threats to persons or property. An example would be a kidnapping that has occurred on campus.

Instances such as these should be reported to a Campus Security Authority. The CSA will report to an Authorized Official who will issue the timely warning. Please refer to the "Campus Security Authority" section for a listing of these individuals.

Timely warnings will be determined on a case-by-case basis and will be based on the following:

- nature of the crime;
- continuing danger to the campus community;
- possible risk of compromising law enforcement efforts.

EMERGENCY RESPONSE AND EVACUATION PROCEDURES

- 1. Any and all members of DEC's administration, faculty, and staff will, and without delay, make a determination if there is a significant emergency or dangerous situation by evaluating the event and/or the environment to determine if there is a health or safety risk present. Significant emergencies and dangerous situations should be reported to an authorized official capable of notifying the proper authorities as well as other staff that will be needed during this event and initiating the notification system. The authorized officials with whom this information should be reported to are listed under "Authorized Officials."
- 2. Generally, the notification system will be communicated campus-wide. However, an authorized official may determine that only segments of the campus community need to receive the notification. This determination will be made on a case-by-case basis and will depend upon the situation itself as well as the level of health and/or safety risk that is present.
- 3. The content of the notification will be determined on a case-by-case basis by an authorized official. The content will be determined based on the situation itself as well as the level of health and/or safety risk that is present.

4. Authorized officials will initiate the notification system as indicated in "Communication During Emergency/Crisis Situations," unless doing so will, in the professional judgment of responsible authorities, compromise efforts to assist a victim or to contain, respond to or otherwise mitigate the emergency. Any or all of the notification systems may be used. The determination as to which, if not all, notification systems will be used is based on the discretion of the authorized official.

Additional information can be found in Douglas Education Center's "Emergency Response and Evacuation Procedures." This document is distributed on an annual basis.

ANNUAL SECURITY REPORT

A key element of the Campus Security Policy is the Annual Security Report. The Annual Security Report identifies the frequency of incidents of criminal offenses, hate crimes, liquor law violations, drug abuse violations and weapons violations.

Crime statistics are compiled in accordance with the definitions used by the Federal Bureau of Investigation's Uniform Crime Reporting (UCR) system, Hate Crime Data Collection Guidelines and the Training Guide for Hate Crimes Collection.

The Annual Security Report covers the three most recently completed calendar years of data. For example, the October 1, 2024 report contains data for calendar years 2021, 2022, and 2023.

The Annual Security Report identifies whether criminal offenses or liquor law, drug abuse and weapons violations occurred on campus, at non-campus facilities, or on public property immediately surrounding the school.

- On-campus means a building or property owned or controlled by the school and used to support the educational purpose.
- A non-campus facility is any building or property owned or controlled by the school or student organization not within the same contiguous area that is used for educational purposes.
- Public property is all public property surrounding the school campus, immediately adjacent to and accessible from the campus.

Hate crimes are listed as a subset of all crimes reported. If there is no evidence a crime was the result of prejudice, it is not listed on the Hate Offenses charts.

Violence Against Women Act (VAWA) offenses identify all reported cases of domestic violence, domestic violence, and stalking.

If an individual was not arrested for an alcohol, drug, and weapons violations, but was referred for school disciplinary action, he or she will be listed on the Disciplinary Action Charts only.

CLERY DEFINITIONS

Murder and Non-Negligent Manslaughter - the willful non-negligent killing of one human being by another.

Negligent Manslaughter - the killing of another person through gross negligence.

Forcible Sex Offenses - any sexual act directed against another person, forcibly and/or against that person's will; or not forcibly or against the person's will where the victim is incapable of giving consent

Non Forcible Sex Offenses - unlawful non-forcible sexual intercourse (A sexual assault offense is classified as a forcible or non forcible sex offense under the uniform crime reporting system of the Federal Bureau of Investigation)

Robbery - the taking or attempting to take anything of value from the care, custody, or control of a person or persons by force or threat of force or violence and/or by putting the victim in fear

Aggravated Assault- an unlawful attack by one person upon another for the purpose of inflicting severe or aggravated bodily injury

Burglary - the unlawful entry of a structure to commit a felony or a theft Motor Vehicle Theft - the theft or attempted theft of a motor vehicle

Arson- any willful or malicious burning or attempt to burn, with or without intent to defraud, a dwelling house, public building, motor vehicle or aircraft, personal property of another, etc.

Arrests and Referrals for Disciplinary Action - for weapons (Carrying, Possessing, Etc.), Drug Abuse Violations and Liquor Law Violations

Hate Crimes - a criminal offense committed against a person or property which is motivated, in whole or in part, by the offender's bias

Rape- rape occurs when a person engages in sexual intercourse with a complainant: (1) by forcible compulsion; (2) by threat of forcible compulsion that would prevent resistance by a person of reasonable resolution; (3) who is unconscious or where the person knows that the complainant is unaware that the sexual intercourse is occurring; (4) where the person has substantially impaired the complainant's power to appraise or control his or her conduct by administering or employing, without the knowledge of the complainant, drugs, intoxicants or other means for the purpose of preventing resistance; or (5) who suffers from a mental disability which renders the complainant incapable of consent.

Domestic Violence - any assault, aggravated assault, battery, aggravated battery, sexual assault, sexual battery, stalking, aggravated stalking, kidnapping, false imprisonment, or any criminal offense resulting in physical injury or death of one family or household member by another family or household member. It is also a pattern of controlling behaviors that may include physical, sexual or emotional abuse. The term "domestic violence" includes felony or misdemeanor crimes of violence committed by a current or former spouse of the victim, by a person with whom the victim shares a child in common, by a person who is cohabitating with or has cohabitated with the victim as a spouse, by a person similarly situated to a spouse of the victim under the domestic or family violence laws of the jurisdiction receiving grant monies, or by any other person against an adult or youth victim who is protected from that person's acts under the domestic or family violence laws of the jurisdiction.

Dating Violence - violence committed by a person who is or has been in a social relationship of a romantic or intimate nature with the victim. The existence of such a relationship shall be determined based on the reporting party's statement and with consideration of the length of the relationship, the type of relationship, and the frequency of interaction between the persons involved in the relationship. For the purposes of this definition, dating violence includes, but is not limited to, sexual or physical abuse or the threat of such abuse. Dating violence does not include acts covered under the definition of domestic violence.

Stalking - stalking occurs when a person either: (1) Engages in a course of conduct or repeatedly commits acts toward another person, including following the person without proper authority, under circumstances which demonstrate either an intent to place such other person in reasonable fear of bodily injury or to cause substantial emotional distress to such other person. or (2) Engages in a course of conduct or repeatedly communicates to another person under circumstances which demonstrate or communicate either an intent to place such other person in reasonable fear of bodily injury or to cause substantial emotional distress to such other person

Consent (in reference to sexual activity) - a knowing and voluntary agreement to engage in specific sexual activity at the time of the activity communicated through clear actions and/or words that are mutually understood. In order to be valid, consent must be active, present and ongoing. Consent is not present when it is the result of coercion, intimidation, force or threat of harm. Consent is not present when an individual is incapacitated due to alcohol, drugs or sleep or otherwise without capacity to provide consent due to intellectual or other disability or condition. Consent can be withdrawn at any time and consent to one form of sexual activity is not necessarily consent to other forms of sexual activity.
